

# **BUSINESS TAX RETURN CHECKLIST**

## ✤ INCOME

If you are not using Xero, then we will need:

- □ Business account bank statements
- $\Box$  Copy of detailed General Ledger

### Other information required:

- □ Interest received on all personal bank accounts and term deposits
- $\Box$  Dividends received from share investments both cash and reinvested
- □ Centrelink benefits, pensions and allowances
- □ Superannuation income streams
- □ Trust distribution statements, including tax statements
- □ Partnership distributions
- □ Capital Gains for any property or investments sold
- □ Foreign source income including overseas pensions

# ✤ DEDUCTIONS

If you are not using Xero, then we will need:

- $\Box$  Interest on any business loans
- □ Business Credit Card statements
- $\Box$  If you have employees, copies of payment summaries issued and any super contributions made
- □ Motor Vehicle if claiming cents per km method then diary entries must support kms claimed. If claiming a percentage of total vehicle expenses, then a log book must be kept for 12 weeks
- □ Lease or Chattel Mortgage details for any vehicles or other equipment owned by the business
- □ Any petty cash expenditure accounted for separately
- $\Box$  Income Protection Premiums

## ✤ INVESTMENT PROPERTIES

- □ Rental Income (an annual statement from a property manager is sufficient)
- □ Any rental property expenses not included on a property manager's statement
- □ Interest paid on any investment property loan or copy of loan statements
- □ Tax Depreciation Schedule (if you have arranged for one to be prepared)
- $\Box$  If you have purchased a property during the year then we will also need:
  - Contract of Sale
  - Settlement Statement
  - o Bank Loan Fees

### ✤ OTHER

#### **Business Related:**

- $\hfill\square$  Value of opening stock at 1 July and closing stock at 30 June
- $\hfill\square$  List of trade debtors and trade creditors at 30 June
- □ Details of any additional business transactions put through personal accounts and credit cards

#### Other:

- $\Box$  Taxable income of your spouse if we don't prepare their return
- □ Annual Private Health Insurance tax statement
- □ Receipts for any donations made to registered charities
- $\Box$  Prior year tax agent fees paid
- □ Personal Super Contributions acknowledgement from your super fund required
- $\Box$  Any after tax super contribution made on behalf of your spouse
- $\hfill\square$  Details of your bank account so the ATO can process your tax refund electronically
